Minutes of the Annual General Meeting of JGECAA

held on 1st March 2025 , at the Club House Premises of Engineers' Club

Proceedings of the meeting are summarized below:

Item No. 1 - Secretary read out the minutes of last AGM held on 23rd March 2024.

Item No. 2 - Secretary read out his report for the year and the house accepted the same.

Item No. 3 – Treasurer placed the Audited Report for the financial year 2023-2024 before the house. The house accepted the same without any modification.

Item No.4 – Selection of Auditor for the financial year 2024 – 2025: The members discussed and decided that the existing CA firm, M/s Gora & Co., having their changed business name as J GUPTA & CO LLP, be engaged as the auditor for the next Financial Year 2024-2025 at the existing honorarium.

Item No.5 - The Treasurer pointed out the scarcity of fund to continue with regular program of the association . The matter was discussed at length and it was unanimously decided that all members shall be requested to continue with their financial assistance of at least Rs. 500/- (Rupees Five Hundred only) per annum to run minimum activities of the association.

Item No. 6 – The election of New Committee was taken up. There was no proposal placed in the meeting for the new committee. The house asked the existing committee to continue for another year. Sri Lakshmi Kanta Ghosh proposed a revised list of names based on member's availability and consent to render their services to the association. The house accepted the same without any modification. The revised list of committee accepted unanimously is attached as Annexure – I. The new committee may induct new Advisory Members and Invitee Members as necessary.

Item No.7 – Sri Abhijit Ray requested Sri Samir Kumar Das to continue interacting with the college authority as necessary.

The President addressed the house with suggestions for improvement of association activities inducting younger members to make the association vibrant and more interactive with the college authority and the current students of the college.

The meeting ended with vote of thanks to the chair.
